## ASSIGNMENT OF INTELLECTUAL PROPERTY

This **ASSIGNMENT OF INTELLECTUAL PROPERTY**, (this "Assignment"), effective as of the 26th day of February, 2014, is by and between Intercontinental Great Brands LLC, a Delaware limited liability company, with a place of business at Three Parkway North, Suite 300, Deerfield, Illinois 60015 ("Assignor"), and Thrive 365 LLC, a Delaware limited liability company, with a place of business at Three Parkway North, Suite 300, Deerfield, Illinois 60015 ("Assignee").

**WHEREAS**, Mondelez Global LLC, a Delaware limited liability company ("MG") and Pilot Lite Ventures USA, Inc. ("PLV") are parties to a certain Professional Services Agreement, effective as of the 1<sup>st</sup> day of July, 2012, as amended as of June 30, 2013, July 31, 2013, September 15, 2013, November 15, 2013 and December 16, 2013, as restated and amended as of January 13, 2014 and as amended as of January 31, 2014 and February 13, 2014 (the "Professional Services Agreement") pursuant to which MG engaged PLV's professional services in connection with the development, management and implementation of a program for consumers who are interested in menu planning that aligns with nutritional recommendations for people with non-insulin dependent type two diabetes (the "Thrive365 Program").

**WHEREAS**, pursuant to that certain Contribution and Assumption Agreement, dated as of February 26, 2014, MG contributed to Intercontinental Brands LLC, a Delaware limited liability company and the sole member of Assignor ("Intercontinental Brands") certain intellectual property owned by MG.

**WHEREAS**, pursuant to that certain Contribution and Assumption Agreement, dated as of February 26, 2014, Intercontinental Brands contributed to Assignor certain intellectual property owned by Intercontinental Brands.

**WHEREAS**, Assignor may have rights, title and interest in and to certain copyrights and copyrightable subject matter, trademarks, internet domain names, patents, inventions (whether patentable or not), confidential and proprietary information, trade secrets, know-how and any other intellectual property and industrial property rights anywhere in the world, including registrations and applications for registration relating to any of the foregoing, in each case related exclusively to the Thrive365 Program, and all goodwill associated with any of the foregoing (the "T365 Intellectual Property").

**WHEREAS**, Assignor has determined that, in its current condition, the T365 Intellectual Property is of nominal value, but in any event has a value not in excess of one dollar (\$1.00 USD).

**WHEREAS**, Assignor desires to assign to Assignee, and Assignee desires to accept from Assignor, the T365 Intellectual Property on the terms set forth below.

**NOW, THEREFORE**, in consideration of the representations, warranties, covenants and disclaimers set forth in this Assignment and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. Assignment.** Subject to the terms and conditions set forth in this Assignment, Assignor hereby conveys, assigns and transfers to Assignee, and Assignee hereby accepts from Assignor, all of the right, title and interest of Assignor in and to all T365 Intellectual Property to the extent in existence and owned by Assignor on the date hereof, including, without limitation, the T365 Intellectual Property listed on Schedule A and all copies and tangible embodiments of the T365 Intellectual Property (in whatever form

or medium) and all past, present and future claims, causes of action and liabilities arising out of or related to any of the T365 Intellectual Property.

**2. Further Assurances.** Assignor agrees, without further consideration, to execute and deliver such further documents as Assignee may reasonably request to effectuate this Assignment and to permit Assignee to be duly recorded as the registered owner of the rights hereby conveyed.

**3. Delivery of Documentation.** To the extent that Assignor is in physical possession or control of any documentation (in whatever form or medium), which relates exclusively to the T365 Intellectual Property, and which is not in the possession of Assignee as of the date hereof, Assignor shall transfer such documentation to Assignee promptly following the date hereof.

**4. Maintenance.** As of the date hereof, Assignee shall have full responsibility for, and bear all costs relating to, the ongoing prosecution and maintenance of any registrations or applications for registration relating to any of the T365 Intellectual Property.

**5. Disclaimers.** THE TRANSFERRED INTELLECTUAL PROPERTY IS ASSIGNED TO ASSIGNEE ON AN "AS-IS", "WHERE-IS" BASIS WITH NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WARRANTIES WITH RESPECT TO NON-INFRINGEMENT, MERCHANTABILITY, TITLE OR FITNESS FOR A PARTICULAR PURPOSE. ASSIGNOR FURTHER DISCLAIMS ANY AND ALL LIABILITY WHATSOEVER WITH RESPECT TO ASSIGNEE'S USE OF THE TRANSFERRED INTELLECTUAL PROPERTY AND ANY OBLIGATIONS OR LIABILITIES ARISING THEREFROM.

**6. Fair Market Value.** Assignor and Assignee agree that, as of the date hereof, the fair market value of the T365 Intellectual Property is not in excess of one dollar (\$1.00 USD).

**7. Governing Law.** This Assignment shall be governed by and construed and enforced in accordance with the laws of Delaware (regardless of the laws that might otherwise govern under applicable principles of choice or conflicts of law) as to all matters, including matters of validity, construction, effect, performance and remedies.

**8. Jurisdiction; Forum.** The parties hereto each hereby irrevocably submit (to the fullest extent permitted by applicable law) to the non-exclusive jurisdiction of any state or federal court in the State of Delaware in any suit or proceeding arising out of or relating to this Assignment, and the parties hereby irrevocably agree that all claims in respect of such suit or proceeding may be heard and determined in such state or federal court in the State of Delaware. The parties hereto each hereby irrevocably waive (to the fullest extent permitted by applicable law) any objection each may now or hereafter have to remove any such suit or proceeding, once commenced, to another court on the grounds of forum non conveniens or otherwise.

**9. No Third Party Beneficiaries.** This Assignment is solely for the benefit of the parties hereto and is not intended to confer upon any other person except the parties hereto any rights or remedies hereunder.

**10. Successors and Assigns.** This Assignment and all of the provisions hereof shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns.

**11. Counterparts.** This Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
