**TO WHOM IT MAY CONCERN:**

The Deputy Commissioner of Finance approved the agreement to merge **COUNTRY CLUB BANK, N. A.**, Shawnee Mission, Johnson County, Kansas, with and into **NORBANK**, North Kansas City, Clay County, Missouri, Charter No. 1425 (the surviving bank), under the Articles of Agreement of **NORBANK**, with the main banking house of the surviving bank to be located at 414 Nichols Road, Kansas City, Jackson County, Missouri. Since it was determined that aforesaid banks were wholly owned by the same bank holding company, the merger took effect immediately upon close of business on April 3, 2009. Pursuant to the agreement of merger, the surviving bank was issued a trust company charter under Charter No. 342 and renamed **COUNTRY CLUB BANK**.
