**RELEASE OF SECURITY INTEREST  
IN TRADEMARK AND PATENT COLLATERAL**

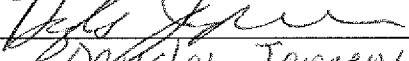
WHEREAS, the Debtor has requested that the Bank release its security interest in all right, title and interest of the Bank in and to the Trademark and Patent Collateral.
