
NUNC PRO TUNC TRADEMARK ASSIGNMENT

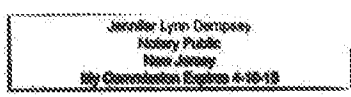

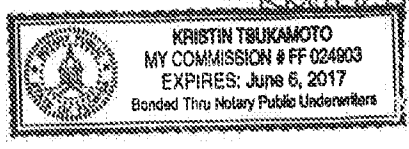
