TRADEMARK ASSIGNMENT

1. Each Assignor hereby sells, transfers, assigns, and delivers to Assignee all of the Assignor's right, title, and interest in, to and under the Marks, together with the goodwill associated therewith; including all applications and registrations therefor. Each Assignor further sells, transfers, assigns, and delivers to Assignee any and all causes of action arising under the rights assigned hereunder that may have arisen prior to the Effective Time. Each Assignor further sells, transfers, assigns, and delivers to Assignee all proceeds to infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto throughout the world for all of the rights herein assigned.


2. Each Assignor agrees to execute and deliver at a future date any additional documents that Assignee reasonably determines are required under any federal or state law, to perfect Assignee's ownership of any intellectual property rights in the Marks.

3. In the event of any conflict between this document and the Purchase Agreement, the Purchase Agreement shall govern.
