INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement ("IP Assignment") dated as of February 15, 2014 is executed and delivered by and among Reward Wall Systems, Inc., a Kansas corporation ("Reward"), Summit ICF Holdings, Inc., a Kansas corporation ("Summit" and together with Reward, each a "Seller" and collectively, the "Sellers") and Airlite Plastics Co., a Nebraska corporation ("Purchaser"). All capitalized terms not otherwise defined in this IP Assignment, shall have the meanings ascribed to them in the Purchase Agreement (as defined below).

WHEREAS, Purchaser, Sellers and Edward L. Storm ("Storm") have entered into that certain Asset Purchase and Sale Agreement dated as of November 14, 2013 (the "Purchase Agreement"), pursuant to which Sellers and Storm agreed to sell, assign, transfer, convey and deliver, free from any encumbrances, unto Purchaser, *inter alia*, all rights, title, and interest in certain intellectual property of Sellers subject in all respects to the terms and provisions of the Purchase Agreement; and

WHEREAS, under the terms of the Purchase Agreement, Sellers have agreed to execute and deliver this IP Assignment, for recording with governmental authorities including, but not limited to, the US Patent and Trademark Office and the US Copyright Office.

NOW THEREFORE, the parties hereto agree as follows:

1. Assignment. In consideration for the execution of the Purchase Agreement, the payment of the consideration set forth in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency are hereby acknowledged, Sellers hereby irrevocably convey, transfer and assign to Purchaser and Purchaser hereby accepts, all of Sellers' right, title and interest in and to the following (the "Assigned IP"):

(a) the patents and patent applications set forth in Schedule 1 hereto and all issuances, divisions, continuations, continuations-in-part, reissues, corresponding foreign patents and patent applications, patents and patent applications claiming priority thereto, extensions, reexaminations and renewals thereof (the "Patents");

(b) the trademark registrations set forth in Schedule 2 hereto, together with the goodwill connected with the use of and symbolized thereby and all issuances, extensions and renewals thereof (the "Trademarks");

(c) the copyright registrations set forth in Schedule 3 hereto and all issuances, extensions, reversionary rights, and renewals thereof (the "Copyrights");

(d) all rights of any kind whatsoever of Sellers accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(f) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Sellers authorize the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other governmental officials to record and register this IP Assignment upon request by Purchaser. Sellers shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure that the Assigned IP is properly assigned to Purchaser, or any assignee or successor thereto.

3. Terms of Purchase Agreement. This IP Assignment is being delivered pursuant to the Purchase Agreement and will be construed consistently therewith. This IP Assignment is not intended to, and does not, in any manner enhance, diminish, or otherwise modify the rights and obligations of the parties under the Purchase Agreement. To the extent that any provision of this IP Assignment conflicts or is inconsistent with the terms of the Purchase Agreement, the terms of the Purchase Agreement will govern.

4. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.

5. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


6. Governing Law. This IP Assignment shall be governed by and construed in accordance with the laws of the State of Nebraska, without giving effect to any of the conflict of law rules thereof to the extent such rules would require or permit the application of the laws of another jurisdiction to this IP Assignment.




