WHEREAS, in a Unit Redemption Agreement dated effective as of June 30, 2011, Orlando Sports assigned all trademarks, service marks, trade dress, logos, graphics, and trade names, and all applications, registrations and renewals in connection therewith, as they relate to the name "Austin Aztex Football Club," or any variation of such name used or owned by Orlando Sports (collectively the "*Aztex Trademark*"), to David Markley ("*Markley*"), an individual residing at 13010 Lamplight Village Avenue, Austin, Texas 78727;

WHEREAS, Orlando Sports now wishes to confirm the assignment of the Aztex Trademarks (including the Registrations) to Markley in this instrument;

NOW, THEREFORE, in consideration of the premises and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties hereto, Orlando Sports does assign, transfer and convey unto Markley, effective as of June 30, 2011, all of its right, title and interest in and to the Aztex Trademarks (including without limitation the Registrations), and all the goodwill of the business symbolized by and associated with the Aztex Trademarks.
