## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 15, 2014, by FIFTH THIRD BANK ("Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in Security Agreement 1 (as defined below) and Security Agreement 2 (as defined below).

### W I T N E S S E T H:

WHEREAS, Granite City Food & Brewery Ltd. ("Grantor") and Secured Party were parties to that certain Trademark Security Agreement dated as of May 10, 2011 ("Security Agreement 1") pursuant to which the Grantor granted a security interest to Secured Party in certain Trademarks (as defined below) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule A hereto;

WHEREAS, Security Agreement 1 was recorded by the Trademark Division of the United States Patent and Trademark Office on May 10, 2011, at Reel 004538, Frame 0069;

WHEREAS, Granite City Food & Brewery Ltd. ("Grantor") and Secured Party were parties to that certain Trademark Security Agreement dated as of December 30, 2011 ("Security Agreement 2") pursuant to which the Grantor granted a security interest to Secured Party in certain Trademarks (as defined below) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule B hereto;

WHEREAS, Security Agreement 2 was recorded by the Trademark Division of the United States Patent and Trademark Office on January 6, 2012, at Reel 4699, Frame 0092 and (ii) January 17, 2012 at Reel 4699, Frame 0017;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks and reassign any and all rights in the same to such Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) all of the Trademarks, all recordings and registrations therefor and applications therefor, all renewals and extensions thereof, all rights corresponding thereto, and all goodwill associated therewith or symbolized thereby including those listed on Schedule A and Schedule B attached hereto (collectively, the "Trademarks"); and

(ii) all proceeds of the foregoing, including, without limitation, all general intangibles embodying, incorporating, evidencing or otherwise relating or pertaining to the Trademarks.

2. Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in and to the Trademarks and the Trademark Collateral.
