TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of the 1 day of July, 2013 (the "Effective Date"), by and between Oracal, USA, Inc., a Delaware corporation, having an address of 1100 Oracal Parkway, Black Creek, Georgia 31308 USA (hereinafter referred to as "Assignor"), and Orafol Americas Inc., a Delaware corporation, legally organized under the laws of Delaware, whose address is 1100 Oracal Parkway, Black Creek, Georgia 31308 USA (hereinafter referred to as "Assignee") (collectively, the "Parties").

WITNESSETH

WHEREAS, Assignor has adopted and used and is the owner of the Federal trademark registration set forth on Schedule A, attached hereto, and incorporated herein by reference (the "Mark");

WHEREAS, the Parties desire to enter into this Assignment to affect the transfer of all right, title, and interest in and to the Mark to Assignee on a worldwide basis.

NOW, THEREFORE, for and in consideration of the premises and the mutual promises hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Transfer and Assignment. Assignor hereby transfers and assigns to Assignee all right, title, and interest in and to the Mark on a worldwide basis, together with the goodwill associated therewith, along with the right to recover for damages and profits and other remedies for past infringements of the Mark.
2. Further Documentation and Actions. Assignor hereby agrees to execute and deliver to Assignee any further documents and instruments, and to do any and all further reasonable and necessary acts to vest in Assignee all right, title, and interest in and to the Mark, and to enable such right, title, and interest for the Mark to be recorded in the United States Patent and Trademark Office and any other appropriate governmental authority or agency of the United States and internationally.
3. Entire Agreement. This Assignment represents the entire agreement between the Parties regarding the Mark and supersedes any previous oral or written agreement, understanding, discussion, or other documentation to the contrary.
4. Construction. This Assignment is governed by Georgia law.
