Pursuant to Section 252(c) of the General Corporation Law of the State of Delaware, Repo Remarketing, Inc., a Delaware corporation (the "Corporation"), hereby certifies as follows:

FIRST: The name and state of incorporation of each of the Corporation and Repo Remarketing, Inc., a California corporation ("Repo California"), which are the constituent corporations in the merger (the "Constituent Corporations"), are as follows:

SECOND: The Agreement of Merger dated as of February 24, 2014 (the "Merger Agreement") by and between the Constituent Corporations has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with the requirements of Section 252 of the General Corporation Law of the State of Delaware.

THIRD: The merger shall become effective (the "Effective Time") at the time of the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

FOURTH: In accordance with the Merger Agreement, at the Effective Time, Repo California will merge with and into the Corporation and the Corporation will continue as the surviving corporation (the "Surviving Corporation"). At the Effective Time, the separate corporate existence of Repo California will cease.

FIFTH: The name of the Surviving Corporation of the merger is Repo Remarketing, Inc.

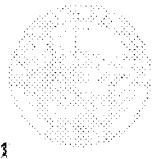

EIGHTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either Constituent Corporation.
