

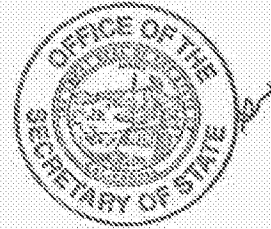



The percentage vote required was more than 50%.
