
**Resolution**

The undersigned, Mark J Appelberg and Mark A Mays, being the sole directors of E-Lite Technologies, Inc. ("E-Lite"), resolve as follows:

1. E-Lite, being the sole member as of the date hereof of Egress Marking Systems, LLC, a Connecticut limited liability company, shall transfer all of its tangible personal property and intangible intellectual personal property to Egress Marking Systems, LLC ("EMS"), as a capital contribution to EMS.
2. Promptly after the transfer above from E-Lite to EMS, E-Lite shall transfer and assign its 100% interest in EMS, LLC, as it exists or may exist with the assets transferred pursuant to the resolution provided in paragraph 1, hereof, to Mark J. WHEREAS, E-Lite desires to transfer assets to EMS;


