TO HAVE AND TO HOLD the Assigned Properties unto Assignee, its successors and assigns, forever, and Assignor does hereby bind itself and its successors to WARRANT and FOREVER DEFEND, all and singular, the title to the Assigned Properties unto Assignee, its successors and assigns, against every person whomsoever lawfully claiming or to claim the same, or in any part thereof, by, through and under Assignor, but not otherwise.

Assignor hereby agrees to perform, execute and/or deliver or cause to be performed, executed and/or delivered any and all such further acts and assurances as Assignee may reasonably require to perfect Assignee's interest in the assets hereby assigned. The conveyance of the Assigned Properties is "AS IS" and "WITH ALL FAULTS" and without warranty as to suitability for a particular purpose or warranty of merchantability.
