

Article 5. (a) Upon the incorporation of the Association, all members of the unincorporated Association shall become members of the incorporated Association with the rights and privileges of membership prescribed by, or in accordance with, the Constitution and Bylaws of the Association.

(b) Upon the incorporation of the Association, all the rights, privileges, immunities, powers, franchises, and authority, and all the property and obligations of the unincorporated Association shall thereupon pass to, vest in, and be obligations of, the incorporated Association.

Article 6. (a) (1) The Association shall indemnify any person who serves the Association without compensation, who was or is a party or is threatened to be made a party to or witness in any threatened, pending or completed action, suit or proceeding, whether civil or criminal, administrative or investigative, by reason of the fact that he or she is or was a Governor, delegate, director or officer of the Association, or is or was serving at the request of the Association without compensation as a member, Governor, delegate, director, trustee or officer of another corporation, partnership or other entity against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by him or her in connection with such action, suit or proceeding to the fullest extent and in the manner set forth in and permitted by the Illinois General Not for Profit Corporation Act and any other applicable law, as may from time to time be in effect. Indemnification shall be available if such person acted in good faith and in a manner he or she reasonably believed to be in, or not opposed to, the best interests of the Association, and, with respect to any criminal action or proceeding, had no reasonable cause to believe his or her conduct was unlawful. Neither payment of indemnification nor reimbursement of expenses shall be deemed compensation.

(2) Such right of indemnification shall not be deemed exclusive of any other rights to which such Governor, delegate, director or officer of the corporation may be entitled.

(b) Expenses actually and reasonably incurred in defending a civil or criminal action, suit or proceeding shall be paid by the Association in advance of the final disposition of such action, suit or proceeding, upon receipt of an undertaking by or on behalf of the member, Governor, delegate, director or officer to repay such amount, if it shall ultimately be determined that such person is not entitled to be indemnified by the Association.

(c) Any right of indemnification shall continue as to a person who has ceased to be such a member, Governor, delegate, director or officer of the Association and shall inure to the benefit of the heirs and personal representatives of such person.

(d) Any member or employee may be indemnified by the Association pursuant to action of the Board of Governors.

(e) The foregoing provisions of this Article shall be deemed to be a contract between the Association and each Governor, delegate, director and officer who serves in such capacity at any time while this Article and the relevant portions of the Illinois General Not for Profit Corporation act and other applicable law, if any, are in effect, and any repeal or modification thereof shall not affect any right or obligations then existing, with respect to any state of facts then or theretofore existing, or any action, suit, or proceeding theretofore or thereafter brought or threatened based in whole or in part upon any such state of facts.

Article 7. At any annual meeting the Articles of Incorporation may be amended upon the concurrent vote of at least two-thirds of the members present and voting in the Assembly and at least two-thirds or 100, whichever is greater, of the members present and voting in the House of Delegates. If the Assembly lacks a quorum when an amendment is scheduled to be considered, the action of the House of Delegates is controlling without Assembly action. If the Assembly and the House disagree, either may direct by two-thirds vote that the proposed amendment be submitted for referendum to the members of the Association. To become effective, an amendment so referred must be adopted by two-thirds of the members voting.

Article 8. The Association may be dissolved upon the concurrent adoption of a resolution of dissolution of at least two-thirds of the members present and voting in the Assembly and at least two-thirds or 100, whichever is greater, of the members present and voting in the House of Delegates.

Article 9. If the Association is dissolved, all its property not needed for payment of its debts and expenses shall be transferred or conveyed to one or more organizations that engage in activities related to the legal profession and that qualify for exemption under Section 501(c)(3) of the Internal Revenue Code of 1986 (or later statutes). The Board of Governors shall select the organizations to which such transfer or conveyance is made and shall determine how the property is apportioned among them. In the absence of such a selection or determination by the Board, it shall be made by a court of competent jurisdiction.
