## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Release*”) is made as of June 18, 2014 (the “*Effective Date*”), by Bank of America, N.A., as administrative agent (in such capacity, the “*Administrative Agent*”), in favor of Findly, LLC (the “*Grantor*”).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement between STG-Fairway Acquisitions, Inc., a Delaware corporation, First Advantage Corporation, a Delaware corporation, the Grantor, the Administrative Agent and the other entities party thereto, dated as of February 28, 2013 (the “*Trademark Security Agreement*”), the Grantor pledged and granted to the Administrative Agent a lien on and security interest in all of its right, title and interest in and to certain collateral identified in said Trademark Security Agreement, including, without limitation, the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the “*Released Trademarks*”);

**WHEREAS**, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on March 11, 2013, at Reel 4977 and Frame 0710;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Released Trademarks arising under the Trademark Security Agreement.

If and to the extent the Administrative Agent has acquired any right, title or interest in or to any of the Released Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Grantor.

This Release is applicable only with respect to the Released Trademarks and to no other collateral under the Trademark Security Agreement. The Administrative Agent retains all security interests, liens, rights, titles and interests granted to the Administrative Agent by any other party thereto under the Trademark Security Agreement.

The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, and at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
