RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of June ~~27~~, 2014, is made by General Electric Capital Corporation, as Agent (the "Grantee"), in favor of CONNOISSEUR MEDIA ACQUISITIONS, LLC, a Delaware limited liability company, and CONNOISSEUR MEDIA OF CONNECTICUT, LLC, a Delaware limited liability company (each a Grantor and collectively, the "Grantors") party to the Trademark Security Agreement (as defined below).


WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of May 29, 2013 and recorded with the United States Patent and Trademark Office on May 31, 2013 at **Reel 5038 Frame 0738** (the "Trademark Security Agreement"), made by Grantors in favor of Grantee, and (ii) the Second Lien Guaranty and Security Agreement (as defined in the Trademark Security Agreement; hereinafter, the "Second Lien Security Agreement"), Grantors pledged and assigned to Grantee, a continuing security interest in the trademarks and intellectual property licenses listed on Schedule 1 attached hereto (collectively, the "Trademarks"), together with, among other things, the goodwill of the business symbolized by and associated with the Trademarks and the applications and registrations thereof, and all proceeds thereof (collectively, including the Trademarks, the "Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (i) terminates the Trademark Security Agreement, and (ii) releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests in the Grantors' Trademark Collateral granted pursuant to the Trademark Security Agreement and/or the Second Lien Security Agreement, including the Trademark Collateral listed on Schedule 1 hereto.
