TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of June 26, 2014, by each of the entities listed on the signature pages hereof, or that becomes a party hereto pursuant to Section 8.14 of the Guarantee and Security Agreement referred to below (each a "Grantor" and, collectively, the "Grantors"), in favor of Capital One, National Association (the "Bank").

Witnesseth:

WHEREAS, pursuant to the Credit Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), between Newtek Business Services, Inc. (the "Borrower") and the Bank, the Bank has agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, the Borrower and the other Grantors are party to a Guarantee and Security Agreement of even date herewith in favor of the Bank (the "Security Agreement") pursuant to which, among other things, each Grantor (other than the Borrower) has guaranteed the Obligations (as defined in the Credit Agreement) and each Grantor has granted in favor of the Bank a Lien on and security interest in all of its respective Property, and each of the undersigned Grantors is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises, to induce the Bank to enter into the Credit Agreement and to make extensions of credit to the Borrower thereunder, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees with the Bank as follows:

Section 1. Defined Terms.

Unless otherwise defined herein, terms defined in the Credit Agreement or in the Guarantee and Security Agreement and used herein have the meaning given to them in the Credit Agreement or the Guarantee and Agreement.

Section 2. Grant of Security Interest in Trademark Collateral.

Each Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations (as such term is defined in the Credit Agreement), hereby mortgages, pledges and hypothecates to the Bank, and grants to the Bank a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the "Trademark Collateral"):

- (a) all of its Trademarks and Trademark Licenses to which it is a party, including, without limitation, those referred to on Schedule I hereto;
- (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (c) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any Trademark

or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

Section 3. Guarantee and Security Agreement.

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Bank pursuant to the Guarantee and Security Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Bank with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Guarantee and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Section 4. Ownership of Trademarks.

Nothing contained in this Agreement, the Credit Agreement, or the Guarantee and Security Agreement, nor any act, omission, or circumstance may be construed as: (a) directly or indirectly conveying to the Bank any rights in and to the Trademarks (other than the security interest granted pursuant to the Guarantee and Security Agreement and all rights with respect thereto) or (b) conveying to the Bank any right of prior approval of, or any right to prevent the granting of, or any right to rescind any license of any of the Trademarks granted by any of the Grantors.


