## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of January 13, 2014 (the "Effective Date") and is by and between Napersoft, Inc. ### ASSIGNMENT OF MARK

1.1. **Assignment.** Assignor has agreed to and hereby recognizes the assignment and transfer to Assignee and its successors and assigns of Assignor's entire right, title and interest in and to the Mark, the Application, and the Goodwill, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its parents, subsidiaries, affiliates, successors, assigns, licensees and legal representatives, as such rights would have been held and enjoyed by Assignor had this Assignment not been made.

1.2. **Warranties.** The Mark, the Application, and the Goodwill are assigned hereunder "as is" without any warranties, express or implied.

1.3. **Further Materials or Documentation.** Assignor agrees to execute any other documents or to provide any further materials or documentation necessary in order to fulfill the provisions of or the purpose of this Assignment or to substantiate either party's use and/or ownership of the Mark, the Application and the Goodwill.

1.4. **Binding Effect.** This Assignment is binding upon the parties and their respective heirs, successors, assigns, trustees, and representatives.
