**TERMINATION AND RELEASE OF
SECURITY AGREEMENT**

THIS **TERMINATION AND RELEASE OF SECURITY AGREEMENT** (this "Release") dated as of the 11th day of July 2014, by and among **CONNECTICUT INNOVATIONS INCORPORATED**, a Connecticut Corporation (the "Secured Party") and **SKYSTREAM MARKETS INC.**, a Delaware corporation ("Debtor").

RECITALS

A. On January 31, 2012, Secured Party and Debtor entered into that certain Security Agreement (the "Security Agreement"), pursuant to which Debtor granted the Secured Party a security interest in and to certain collateral of the Debtor as set forth on Schedule A hereto (the "Collateral"). The Security Agreement was recorded at Reel/Frame 4746/0036 with the U.S. Patent and Trademark Office (the "USPTO").

B. The Obligations (as defined in the Security Agreement) have been fully satisfied and the parties desire to terminate the Security Agreement and the Secured Party has agreed to release the security interest in and to the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. Release and Termination of Security Agreement. The Security Agreement is hereby terminated. Secured Party further hereby terminates and releases its security interest in and to the Collateral, and the Secured Party hereby assigns and transfers to the Debtor, without representation, warranty or recourse of any kind or nature, all of the Secured Party's right, title and interest in and to the Collateral. The Debtor hereby acknowledges and accepts the foregoing release and assignment by the Secured Party.
2. Authorization. Secured Party hereby authorizes the Debtor, at the expense of the Company, to file this Release in the applicable filing and recording offices to effect a complete release of the Collateral.
3. Governing Law. This Release will be governed by and construed in accordance with the laws of the State of New York, applicable to contracts to be made and wholly performed within such state.
4. Counterparts. This Release may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which shall be deemed to be an original, but all of which taken together constitute one and the same instrument.
