
ASSIGNMENT

I Claude Lenoir, the PRESIDENT of AFFIVAL, verify that I have firsthand knowledge of the facts, as follows. AFFIVAL is the owner of the United States trademark registration number 1305582. On November 13, 1990 a request was filed with the Assignment Branch of the United States Patent and Trademark Office requesting recordal of an assignment from the original registrant Vallourec to AFFIVAL. The assignment deed submitted in support of the request for recordal erroneously identified the assignee as "Affival, S.A." instead of only "AFFIVAL." The legal entity-type "S.A." has never been used as part of the name of the registrant company AFFIVAL and the company is properly identified only as AFFIVAL, without the designation of its legal-entity-type "Société Anonyme". With this request, the assignee and current trademark owner AFFIVAL therefore requests recordal of a corrected assignment to properly identify the registrant as AFFIVAL. A copy of the Deed as filed is attached herewith, initialing and dating the areas of the old deed that require correction.

ASSIGNMENT OF TRADEMARK
