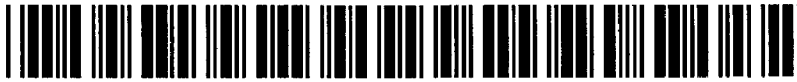

RESOLVED, that Article FIRST of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

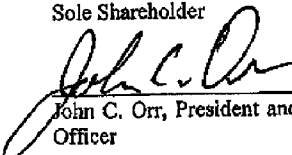
The name of the corporation is Scepter US Holding Company
