RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of July 21, 2014, is made by General Electric Capital Corporation, a Delaware corporation, as administrative agent ("Grantee"), in favor of Jobson Medical Information LLC, a Delaware limited liability company ("Grantor"). All capitalized terms not otherwise defined herein shall have the meanings set forth in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of April 22, 2013 and recorded with the United States Patent and Trademark Office (the "USPTO") on April 30, 2013 at Reel 5017, Frame 0986 (the "Trademark Security Agreement"), made by the Grantor in favor of Grantee, a continuing Security Interest was granted by Grantor to Grantee in all of the Trademark Collateral, including the Trademarks listed on Schedule A hereto; and

WHEREAS, the Grantee desires to release any and all liens on and security interests in the Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed on Schedule A hereto, granted pursuant to the Trademark Security Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby releases, without any representation, recourse or undertaking by the Grantee, any and all liens on and security interests in the Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed on Schedule A hereto, granted pursuant to the Trademark Security Agreement and hereby terminates the Trademark Security Agreement.

Upon the request of Grantor, Grantee further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest; provided that all such documents are to be prepared by counsel to the Grantor and the cost and expense of such documents shall be borne solely by Grantor.
