demands, rights, and interests it may have, its entire right, title and interest in and to the Registration, and its entire right title and interest, whether statutory or at common law, in and to the Mark, together with the goodwill of the business symbolized by the Mark, in all countries throughout the world, together with all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements. Assignor agrees to execute further papers and at the Assignee's request and expense to do such other reasonable acts as may be necessary and proper to vest full record title in and to the Registration in the Assignee.

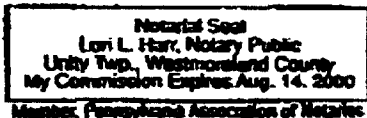
