ARTICLES OF CONVERSION

TO CONVERT

PETRA INDUSTRIES, INC., AN OKLAHOMA CORPORATION

TO

PETRA INDUSTRIES LLC
AN OKLAHOMA LIMITED LIABILITY COMPANY

These Articles of Conversion are hereby executed effective as of the 30th day of June, 2014 for the purpose of converting Petra Industries, Inc., an Oklahoma corporation (the "Converting Entity"), into Petra Industries LLC, an Oklahoma limited liability company (the "Converted Entity"), as provided for in the Oklahoma Limited Liability Company Act at 18 Okla. Stat. § 2054.1 and in the Oklahoma General Corporation Act at 18 Okla. Stat. § 1090.5. The provisions of these Articles of Conversion are as follows:

1. The name of the Converting Entity is Petra Industries, Inc. an Oklahoma corporation.
2. The name of the Converted Entity is Petra Industries LLC, an Oklahoma limited liability company.
3. The Converting Entity is continuing its existence in the organizational form of the Converted Entity.
4. The Converted Entity is a limited liability company organized under the laws of the State of Oklahoma on January 25, 2007.
5. The Articles of Organization of the Converted Entity are attached hereto as Exhibit "A".
