Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act.

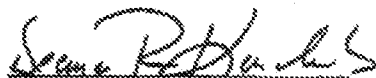
- First:** The name of the surviving corporation is ACCOUNTING PRINCIPALS, INC., a Foreign Corporation.

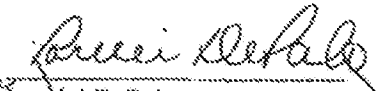
Ninth: The merger is to become effective on January 1, 2011, at 12:03 AM.
