RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release") is made as of July 16, 2014 ("Effective Date") by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, in its capacity as Collateral Agent (in such capacity, the "Collateral Agent") for the benefit of SHERIDAN HEALTHCARE, INC. (the "Company").

WHEREAS, pursuant to the terms and conditions of that certain First-Lien Intellectual Property Security Agreement dated as of December 31, 2012 by and between the Company and the Collateral Agent (the "Intellectual Property Security Agreement"), the Company granted to the Collateral Agent for the benefit of the First-Lien Secured Parties a security interest in all of its right, title and interest in and to the United States Trademark registrations and applications set forth in Schedule A hereto (collectively, the "Trademark Collateral"); and

WHEREAS, the Intellectual Property Security Agreement was executed by the Company and was previously recorded in the United States Patent and Trademark Office ("USPTO") on March 13, 2013 at Trademark Reel No. 4981, Frame No. 0241; and

WHEREAS, the Collateral Agent has agreed to release the grant of its security interest in all of the right, title, and interest of the Company in the Trademark Collateral, and to reconvey any and all rights in the Trademark Collateral to the Company;


NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby releases, relinquishes and discharges, all of its security interest in all of the Company's right, title and interest in, to and under the Trademark Collateral, and re-assigns to the Company any and all right, title or interest it may have in such Trademark Collateral, all without warranty and representation of any kind.

The Collateral Agent hereby authorizes the Company, or the Company's authorized representatives to: (a) record this Release with the USPTO and/or any other applicable governmental office or Agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Trademark Collateral.
