NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made as of January 1, 2014, by and between Activa Health Services, Inc. dba Elevate Health, a corporation organized and existing under the laws of California and having its principal place of business at 201 Covina, #4, Long Beach, California 90803 ("Assignor"), and Elevate Home Health, LLC, a limited liability company organized and existing under the laws of California and having its principal place of business at 201 Covina, #4, Long Beach,, California 90803 ("Assignee" and with Assignor, the "Parties").

WHEREAS, the Parties entered into an Asset Purchase Agreement, dated January 1, 2014, pursuant to which Assignor sold and transferred to Assignee, and Assignee acquired from Assignor, the assets of Assignor's home health agency, including the U.S. trademark registrations listed in the attached Schedule (the "Marks"), and all of Assignor's right, title, and interest in and to the Marks, including all common law rights, together with the goodwill of the business associated therewith, and the Parties wish to record this assignment at the U.S. Patent and Trademark Office ("USPTO") against the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

Assignor hereby assigns to Assignee, effective as of January 1, 2014, all of Assignor's right, title, and interest in and to: (i) the Marks, together with the goodwill of the business symbolized by the Marks; (ii) the right to bring an action at law or in equity for any infringement, dilution, or violation of the Marks occurring prior to the date of this Assignment, and to collect all damages, settlements, and proceeds arising from such action at law or in equity; and (iii) all administrative rights arising from or relating to the Marks, including, without limitation, the right to maintain the registration and the right to oppose, seek to cancel, or otherwise dispute claims to marks or mark registrations asserted or owned by others.

This Assignment may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
