Assignor confirms that it has authorized the Commissioner of Patents and Trademarks to record the registration(s) of the Mark as the property of Assignee and to issue all future registrations for the Mark to Assignee.

Assignor confirms that Assignor has agreed to execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Mark.

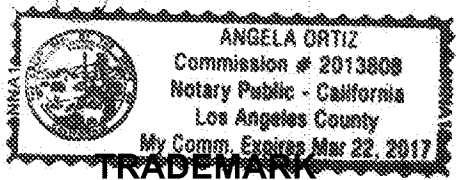
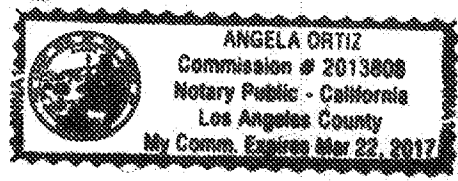
