**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK COLLATERAL**

This Release ("**Release**") is made with regard to that certain Intellectual Property Security Agreement entered into as of April 23, 2009 ("**Agreement**") by and between VENTURE LENDING & LEASING IV, INC., and VENTURE LENDING & LEASING V, INC. both Maryland corporations ("**Lenders**") and KAREO, INC. a California corporation ("**Company**").

Lenders represent and warrant that they have not transferred or assigned all or any part of the Security Interest in the Collateral to any third party, and that they have all necessary authority to execute this Release.
