Dear Sir or Madam:

On September 9, 2014, an assignment was filed with the USPTO Trademark Assignment Division assigning the EASY DNS mark, Serial No. 77263927 from EasyDNS Technologies, Inc., a Canadian entity, to EasyZone Acquisition Corp, a Canadian entity. We represent both parties. The assignment agreement attached to the September 9, 2014 assignment referenced another mark, ZONEEDIT (Serial No. 78105767). Thus, by mistake, the ZONEEDIT assignment was filed in association with the EASY DNS mark and the EASY DNS mark was inaccurately assigned from EasyDNS Technologies, Inc. to EasyZone Acquisition Corp.

On that same day, Registrant's attorney of record filed a preliminary amendment with the USPTO rescinding this assignment. On September 20, 2014, the examining attorney assigned to the EASY DNS mark issued an office action requesting clarification of the chain of title associated with the EASY DNS mark. On September 22, 2014, Registrant's attorney of record was instructed in a telephone conversation with the examining attorney to file a document rescinding the assignment with the Trademark Assignment Division, file a response to the office action, and file a corrective amendment associated with the mark.

This letter serves as Applicant's formal request to rescind the assignment filed in association with the EASY DNS mark. The registrant of the EASY DNS mark should read, "EasyDNS Technologies, Inc. CORPORATION CANADA 304A –
