1.2 Assignor further covenants that it will cooperate with Assignee in the execution of all documents, papers, forms and authorizations and take other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Assigned Trademarks.

ASSIGNMENT OF PATENTS

2.1 As of May 13, 2014, Assignor hereby conveyed transferred, and assigned to Assignee all of Assignor's right, title and interest in and to the Assigned Patents along with all patent and intellectual property rights related to subsequent provisional or divisional applications filed with respect thereto, together with all claims that can or may be asserted by Assignor arising out of or relating to the use or ownership of any of the Assigned Patents.

2.2 Assignor further covenants that it will cooperate with Assignee in the execution of all documents, papers, forms and authorizations and take other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Assigned Patents.
