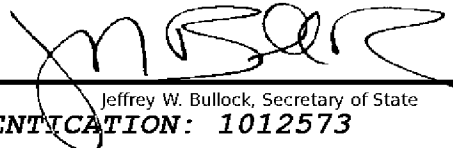

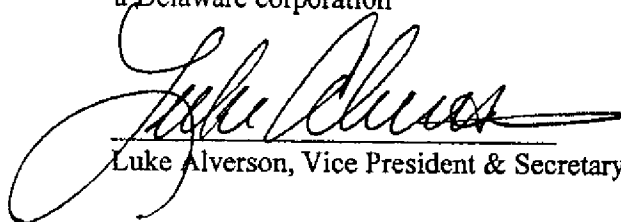
1. The name of the surviving corporation is Flowserve US Inc., a corporation organized and existing under the laws of the State of Delaware.
