RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "*Release*") is made as of August 4, 2014 (the "*Effective Date*") by H.I.G. GROWTH PARTNERS – PAWSPLUS, LLC, with an office at 1380 West Paces Ferry Road, Suite 1290, Atlanta, GA 30327 (referred to herein individually as the "*Grantee*"), in favor of Pet Services Holdings, Inc., a Delaware corporation ("*Holdings*"), PawsPlus Management, Inc., a Delaware corporation ("*PawsPlus*"), Vetco Hospitals Corp., a Delaware corporation ("*Vetco*"), Pet Services Operating Corporation, a Delaware corporation ("*Pet Services*"), Pet Internet Services, Inc., a Delaware corporation ("*Pet Internet*"), and Vet Wellcare, Inc., a Delaware corporation ("*VW*" and together with Holdings, PawsPlus, Vetco, Pet Services and Pet Internet, the "*Grantors*" and individually a "*Grantor*") each with an office at 7115 16th Street East, Sarasota, FL 34243.

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of December 21, 2010 (the "*Security Agreement*"), the Grantors granted the Grantee a security interest in and to certain intellectual property owned by the Grantors, including, without limitation the intellectual property listed on Annex I attached to this Release (collectively (the "*Intellectual Property Collateral*");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office (the "*USPTO*") on December 30, 2010 at Reel. No 004444 and Frame No. 0906; and

WHEREAS, each Grantor has fulfilled its Obligations (as defined in the Security Agreement), and Grantee now desires to terminate the Security Agreement and release its security interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Grantee hereby covenants and agrees as follows:

1. Grantee hereby terminates, releases, and discharges its security interest in the Intellectual Property Collateral, and reassigns to Grantors any and all right, title, and interest Grantee may have in or to the Intellectual Property Collateral pursuant to the Security Agreement, without representation or warranty of any kind, nature or description.
2. Grantee hereby terminates the Security Agreement. Grantee agrees to cooperate with Grantors in the recordation of this Release, and to execute any other documents reasonably required to evidence the termination of the Security Agreement and release of any right of Grantee in and to the Intellectual Property Collateral.
3. Grantee hereby affirms that it has no security interest in any Grantor's license to use the trademark "VETCO" (the "*Trademark*") pursuant to the Vaccination Clinic Services Agreement by and between Petco Animal Supplies Stores, Inc. and Vetco Hospitals Corp., dated as of December 21, 2010, as amended, that certain Agreement by and between Petco Animal Supplies, Inc. and Vetco Hospitals, Inc., dated October 8, 1996, or otherwise, and to the extent


Grantee has a security interest in any Grantor's license to use the Trademark, Grantee hereby terminates, releases, and discharges its security interest in such license.
