**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

WHEREAS, the Pledgor has met its obligations under the Security Agreement and has requested that Secured Party release its security interest in all right, title and interest in, to and under the IP Collateral.

NOW, THEREFORE, Secured Party, without recourse and at the Pledgor's sole cost and expense, hereby terminates, cancels and releases the security interest in the IP Collateral and any and all right, title and interest of Secured Party in the IP Collateral shall hereby terminate, cease and become void.


