## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 7, 2014, is made by Fifth Third Bank (together with its successors and assigns, the "Lender").

**WHEREAS**, Capstone Logistics, LLC, a Delaware limited liability company ("Grantor"), granted a security interest in certain property to the Lender, including, without limitation, a security interest in certain trademark collateral, pursuant to that certain Trademark Security Agreement dated as of March 18, 2013 (the "Trademark Security Agreement");

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office as follows: on April 4, 2013 at Reel 004998 and Frame 0174; and

**WHEREAS**, the Lender has agreed to terminate and release its security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks identified on Schedule 1.

**NOW, THEREFORE**, for valuable consideration, the Lender hereby terminates, discharges, cancels and releases all mortgages, liens and security interests granted to the Lender with respect to the Trademark Collateral, and re-conveys and re-assigns to the Grantor, without representation, warranty, recourse or undertaking by the Lender, all of the Lender's right, title and interest, if any, in and to the Trademark Collateral. The Lender agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Termination of Security Interest in Trademarks.
