## INTELLECTUAL PROPERTY ASSIGNMENT

WHEREAS, PokerTek, Inc., a North Carolina corporation having offices at 1150 Crews Road, Suite F, Matthews, North Carolina 28105 ("PokerTek"), owns and has acquired certain intellectual property including, but not limited to, patents, trademarks, domains, and copyrights (the "Intellectual Property").

WHEREAS, Multimedia Games, Inc., a Delaware corporation having an office at 206 Wild Basin Road South, Building B, 4<sup>th</sup> Floor, Austin, Texas 78746 ("Multimedia Games"), desires to acquire the entire right, title, and interest in the Intellectual Property.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, PokerTek does hereby sell, assign, and transfer unto Multimedia Games, the entire right, title, and interest that exist today and may exist in future and to any and all of the following:

- a) the issued patents and patent applications listed in Exhibit 1, and in and to any and all patent applications and letters patent wherever they may be filed or granted thereon including continuation or divisional patent applications, reissues and extensions, the same to be held and enjoyed by Multimedia Games for its own use, and for its legal representatives and assigns, to the full end of the term or terms for which letters patent are or may be granted, reissued, or extended, as fully and entirely as the same would have been held or enjoyed by me had this assignment not been made;
- b) the trademarks, servicemarks, registrations, and applications listed in Exhibit 2, and any and all common law rights and the good will of the business symbolized thereby relating to the marks, and all rights, including copyrights, trade dress, artwork, math, sound, and all other intellectual property associated with the marks including each PokerTek product, past and present;
- c) the domains listed in Exhibit 3;
- d) the licenses listed in Exhibit 4;
- e) additional miscellaneous Intellectual Property owned by PokerTek including gaming tables, games, inventions, invention disclosures, software (owned and licensed) and designs stored or represented in various media including any notes, algorithms, drafts, and partial works; and
- f) all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Intellectual Property and/or any item in any of the foregoing categories (a) through (e), including without limitation, all causes of action and other enforcement rights for:
  1. damages, past, present, or future;
  2. injunctive relief;
  3. any other remedies of any kind for past, current, and future infringement; and
  4. royalties and other payments.

For the same consideration set forth herein, PokerTek hereby represents and warrants to Multimedia Games, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles, and/or interests that have arisen to Multimedia Games under law or that have already been transferred to Multimedia Games, PokerTek is the sole and lawful owner of the entire right, title, and interest in and to the Intellectual Property, and that the same are unencumbered, except as expressly set forth in the Agreement and Plan of Merger, dated April 29, 2014, by and among Multimedia Games, PokerTek, and 23 Acquisition Co., a wholly owned subsidiary of Multimedia Games (the "Merger Agreement"), and that PokerTek has good and lawful authority to sell and convey the same in the manner according to the terms of this Intellectual Property Assignment and the Merger Agreement.

For the same consideration set forth herein, PokerTek hereby covenants and agrees to and with Multimedia Games, its successors, legal representatives, and assigns, that PokerTek will sign all papers and documents, take all lawful oaths and declarations, and do all acts necessary or required to be done for the procurement, maintenance, enforcement, and defense of any of the Intellectual Property.

PokerTek hereby authorizes the respective patent, trademark, or governmental office or agency in each jurisdiction to issue any and all patents, certificates of invention, utility models, registrations, or other governmental grants or issuances that may be granted upon any of the Intellectual Property in the name of Multimedia Games, and its assigns and successors, as the assignee to the entire interest herein.

The terms and conditions of this Intellectual Property Assignment will inure to the benefit of Multimedia Games, its successors, assigns, and other legal representatives.

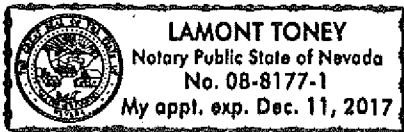
