## TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY

This TERMINATION AND RELEASE dated as of October 16, 2014, from THE GOVERNOR AND COMPANY OF THE BANK OF IRELAND, an Ireland limited liability company as collateral agent for the Secured Parties (the “Collateral Agent”), to AMI ENTERTAINMENT NETWORK, LLC, a Delaware limited liability company (the “Borrower”).

### WITNESSETH:

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of October 18, 2013 among the Borrower, AMI Entertainment Holdings LLC, each of the other grantors party thereto and the Collateral Agent, the Collateral Agent and the Borrower have executed an Intellectual Property Security Agreement dated as of October 18, 2013, and recorded in the United States Patent and Trademark Office at Trademark Reel 5141 Frame 0852 (the “IP Security Agreement”);

WHEREAS, pursuant to the IP Security Agreement, a security interest (the “Security Interest”) was granted by the Borrower to the Collateral Agent in the trademark set forth on Schedule 1 hereto and the license agreement set forth on Schedule 1 hereto to the extent related to the goods of such trademark (collectively, the “Released Collateral”);

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Released Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby states as follows:

Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges the Security Interest in and any and all claims against the Released Collateral, and any right, title and interest of the Collateral Agent in such Released Collateral shall hereby cease and become void.
