RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

WHEREAS, the Grantor and the Assignee entered into that certain Patent and Trademark Security Agreement dated November 18, 2013 (the "Patent and Trademark Security Agreement"), to record the security interest granted to Assignee in all of Grantor's right, title and interest in, to and under in all of Grantor's right, title and interest in, to and under the Patents (listed on Schedule A) and Trademarks (listed on Schedule B), whether owned or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of Grantor's Obligations;

WHEREAS, the Grantor requests a specific release of the security interest granted and recorded against the Patents and Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby terminates the Patent and Trademark Security Agreement and releases and re-assigns to the Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Patents and Trademarks, together with the goodwill of the business symbolized thereby.
