## TRADEMARK ASSIGNMENT

Robert King agrees to communicate with King's Camo any facts known to it relating to said Trademark Rights and will, upon request and at King's Camo's expense, transfer all files including the certificate of registration to King's Camo, testify in any legal proceedings, sign all lawful papers, execute all trademark filing and prosecution documents and generally do all other acts necessary or expedient to assist and enable King's Camo to obtain and enforce full benefits from the right, title and interest herein

assigned. This assignment shall be binding upon Robert King's successors, executors, administrators, and/or assigns.

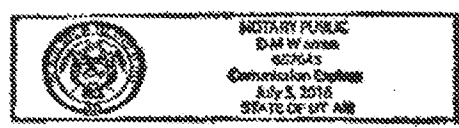
