## MEMORANDUM OF TRADEMARK ASSIGNMENT

**WHEREAS**, on December 3, 2010, Lincoln Plaza Associates, a Pennsylvania limited partnership, with an address of 225 West Washington Street, Indianapolis, Indiana 46204 ("**Assignor**") and Lincoln Plaza Center, L.P., a Delaware limited partnership with an address of 225 West Washington Street, Indianapolis, Indiana 46204 ("**Assignee**") entered into that certain Bill of Sale and Blanket Assignment (the "**Agreement**") under which Assignor transferred and assigned, among other things, all rights and intangible property owned by Assignor in connection with certain real property (commonly known as the LINCOLN PLAZA® retail property) that was also transferred pursuant to said Agreement; and

**WHEREAS**, Assignee desires to clarify the record to show that it now, and has since the effective date of the Agreement, owned all rights, title and interest in and to the mark LINCOLN PLAZA® (the "**Mark**"), along with the goodwill of the business pertaining thereto and including United States Trademark Registration No. 2,907,731 (the "**Registration**") therefor; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, this *nunc pro tunc* assignment is hereby executed to affirm that all rights, title and interest in and to the Mark, the Registration, the goodwill of the business related to the services for which the Mark is registered, and all rights Assignor had enjoyed thereunder, were, in fact, transferred and assigned to Assignee on or about December 3, 2010, and to confirm that Assignee has been the legal and equitable owner of the Mark, the Registration, and the goodwill symbolized by the Mark since that time.




