This Assignment is made 14 July 2014 between:

- (1) Solus Garden and Leisure Limited (in administration) a company incorporated in England and Wales with registration number 01446778 whose registered office is at Benson House, 33 Wellington Street, Leeds, West Yorkshire LS1 4JP (the "Assignor");
 - (2) Robert Jonathan Hunt and Anthony Steven Barrell both of PricewaterhouseCoopers LLP, Cornwall Court, 19 Cornwall Street, Birmingham B3 2DT as the joint administrators of the Assignor (the "Administrators"); and
 - (3) The Scotts Company (UK) Limited a company incorporated in England and Wales with registration number 02824130 whose registered office is at Salisbury House, Wayside Park, Catteshall Lane, Godalming, Surrey GU7 1XE (the "Assignee"),
- each a "Party" and together the "Parties".

Whereas:

- (A) The Administrators were appointed as joint administrators of the Assignor on 15 May 2014.
- (B) The Assignor has agreed, pursuant to the BSA, to assign to the Assignee such right, title and interest (if any) as the Assignor has in and to the Intellectual Property Rights upon the terms set out in this Assignment.

It is agreed as follows:

1 Interpretation:

1.1 Definitions

Unless the context requires otherwise, capitalised words and phrases used but not defined in this Assignment shall have the same meanings as attributed to them in the BSA.

In this Assignment:

"BSA" means the Business Sale Agreement dated on or about the date of this Assignment between the Assignor, the Administrators and the Assignee relating to the sale and purchase of certain assets of the Assignor;

"Designs" means the registered designs listed in Schedule 2;

"Domain Names" means the domain names listed in Schedule 3;

"Intellectual Property" means trade marks, service marks, trade names, logos, get-up, patents, petty patents, utility models, supplementary protection certificates, inventions, registered and unregistered design rights, copyrights, database rights, domain names and URLs, rights in social media accounts, rights to sue for passing off and in unfair competition and all other similar rights in any part of the world (including Know-how), including all unregistered rights and, where such rights are obtained or enhanced by registration, any registration of such rights and applications and rights to apply for such registrations;

"Intellectual Property Rights" means any Intellectual Property owned by the Assignor which has been, or, at Completion, is used in the Business by Assignor, including the Trade Marks, the Designs, the Domain Names and the rights in Social Media Accounts (excluding any Intellectual Property in the name "Nortene");

"Know-how" means industrial and commercial information and techniques in any form (not in the public domain) including drawings, formulae, test results, project reports, and testing procedures, instruction and training manuals, tables of operating conditions, market forecasts and lists and particulars of customers and suppliers;

"Social Media Accounts" means the rights in the social media accounts listed in Schedule 4; and

"Trade Marks" means the registered trade marks and trade mark applications, details of which are set out in Schedule 1.

1.2 Modification and Re-enactment of Statutes

References to a statutory provision include that provision as modified or re-enacted from time to time.

1.3 Recitals, Clauses etc.

References to this Assignment include its Recitals and the Schedules and references to Recitals, Clauses and the Schedules are to Recitals, Clauses of, and the Schedules to, this Assignment.

1.4 Legal Terms

References to any English legal term shall, for any jurisdiction other than England and Wales, be construed as references to the term or concept which most nearly corresponds to it in that jurisdiction.

2 Assignment

The Assignor hereby assigns to the Assignee such right, title and interest (pursuant to statute or common law, if any) as the Assignor has in and to the Intellectual Property Rights including all the goodwill attaching to and represented by any of the Trade Marks but no other goodwill; including without limitation:

- (i) all rights of action, powers and benefits in respect of the Intellectual Property Rights; and
- (ii) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the Intellectual Property Rights whether occurring before, on or after the date of this assignment.

3 Further Assurance

3.1 The Assignor agrees, at the Assignee's request and expense and for the period that the Administrators are in office, to perform (or procure the performance of) further acts and things, and execute and deliver (or procure the execution or delivery of) further documents required by law or which the Assignee reasonably requests to vest in the Assignee the full benefit of the right, title and interest assigned to the Assignee under this Assignment, including, but not limited to:

- (i) assistance in registering the Assignee as applicant for, or proprietor of, the registrable Intellectual Property Rights;

- (ii) providing log-in details to any Social Media Accounts; and
- (iii) authorizing the registrar of the Domain Names to transfer and record the Domain Names in the name of the Assignee, or its nominated administrative contract,

to the extent that the Assignor can do such things or take such actions.

3.2 Any such additional deeds or documents shall be in terms consistent with this Assignment and in a form acceptable to the Administrators' Solicitors and will include the exclusion of personal liability of the Administrators.

4 Exclusions

4.1 Exclusions of Warranties

All representations, warranties, conditions, guarantees and stipulations, express or implied, statutory, customary or otherwise in respect of the Intellectual Property Rights to be transferred pursuant to this Assignment are to the extent legally permitted expressly excluded (including without limitation warranties, conditions as to title, rights to dispose, quiet possession, freedom from encumbrances, merchantable or satisfactory quality, fitness for purpose and description). Except as expressly set out in this Assignment, the schedules are for guidance only and are not an exhaustive or complete list of the items in question and shall not constitute any warranty in respect of the Assignor's ownership of or interest in the listed items or otherwise.

4.2 Condition of assets

The Intellectual Property Rights are sold as at the Completion Date and subject to all faults, liens, executions, distrains, encumbrances and claims of third parties, of which the expense of discharging shall be met by the Assignee. Unless otherwise required by law (and then only to that extent), neither the Assignor nor the Administrators shall be liable for any loss or damage of any kind whatever, consequential or otherwise, arising out of, or due to, or caused by any defects or deficiencies in any of the Intellectual Property Rights.

4.3 Assignee's acknowledgement

4.3.1 The Assignee agrees that the terms and conditions of this Assignment and the exclusions and limitations contained in it are fair and reasonable having regard to the following:

- (i) that this is a sale by insolvent companies in circumstances where it is usual that no representations and warranties can be given by or on behalf of the Assignor or the Administrators;
- (ii) that the Assignee has relied solely upon the opinions of itself and its professional advisors concerning the Intellectual Property Rights;
- (iii) that the Assignee has agreed to purchase the Intellectual Property Rights "as seen" in their present state and for a consideration which takes into account the risk to the Assignee represented by the parties' belief that the said exclusions and limitations are or would be recognised by the courts; and
- (iv) that the Assignee, its representatives and advisers have been given every opportunity it or they may wish to have to examine and inspect all or any of

the Intellectual Property Rights and all relevant documents relating to them and to obtain information from the Assignor and/or the Administrators relating to the Intellectual Property Rights.

- 4.3.2 The Assignee acknowledges that any liability of the Assignor which arises in any way and to any party (whether a party to this Assignment or not) under or pursuant to this Assignment shall not comprise a liability falling within any of the subparagraphs of paragraph 99 of Schedule B1 to the Insolvency Act 1986 and the Administrators shall be under no obligation or duty to treat it as such.

4.4 No Rescission

The Assignee acknowledges that failure to assign any of the Intellectual Property Rights, or if the Assignor does not have title or unencumbered title to any or all of the Intellectual Property Rights, or if it is required to relinquish possession of all or any of the Intellectual Property Rights, or if the Assignee cannot exercise any right conferred or purported to be conferred on it by this Assignment, this shall not be a ground or grounds for rescinding, avoiding or varying any or all of the provisions of this Assignment, or for any reduction or repayment of any part of the consideration paid or payable or of any other form of compensation by way of damages.

5 Whole Agreement

- 5.1 This Assignment and the BSA contain the whole agreement between the Parties relating to the subject matter of this Assignment at the date of this Assignment to the exclusion of any terms implied by law which may be excluded by contract and supersedes any previous written or oral agreement between the parties in relation to the matters dealt with in this Assignment.
- 5.2 To the extent that the terms of this Assignment and the BSA conflict, the terms of the BSA shall prevail.
- 5.3 The Assignee acknowledges that it has not been induced to enter into this Assignment by any representation, warranty or undertaking not expressly incorporated into it.
- 5.4 So far as is permitted by law and except in the case of fraud, each of the parties agrees and acknowledges that its only right and remedy in relation to any representation, warranty or undertaking made or given in connection with this Assignment shall be for breach of the terms of this Assignment to the exclusion of all other rights and remedies (including those in tort or arising under statute).

6 Administrators' Liability

- 6.1 The Administrators have entered into and signed this Assignment as agents for and on behalf of the Assignor and neither they, their firm, partners, employees, agents, advisers or representatives shall incur any personal liability whatever in respect of any of the obligations undertaken by the Assignor; or in respect of any failure on the part of the Assignor to observe, perform or comply with any such obligations; or under or in relation to any associated arrangements or negotiations; or under any document or assurance made pursuant to this Assignment. The Administrators are party to this Assignment in their personal capacities only for the purpose of receiving the benefit of all limitations, exclusions, undertakings, covenants and indemnities in their favour contained in this Assignment.

7 Governing Law and Jurisdiction

- 7.1 This Assignment and any non-contractual obligations arising out of or in connection with it or its subject matter are governed by English law.
- 7.2 The parties agree that the courts of England are to have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this Assignment or its subject matter (including a dispute relating to the existence, validity or termination of this Assignment or any non-contractual obligation arising out of or in connection with this Assignment (a "Dispute")) and that accordingly any such legal action relating to a Dispute shall be brought in such courts.
- 7.3 The parties irrevocably submit to the jurisdiction of such courts and waive any objection to any legal action or proceedings in any such court on the grounds of venue or on the grounds that such legal action or proceedings have been brought in an inconvenient forum.

8 Invalidity

- 8.1 If any provision in this Assignment shall be held to be illegal, invalid or unenforceable, in whole or in part, the provision shall apply with whatever deletion or modification is necessary so that the provision is legal, valid and enforceable and gives effect to the commercial intention of the parties.
- 8.2 To the extent it is not possible to delete or modify the provision, in whole or in part, under Clause 8.1, then such provision or part of it shall, to the extent that it is illegal, invalid or unenforceable, of the remainder of this Assignment shall, subject to any deletion or modification made under Clause 8.1, not be affected.


9 Counterparts

This Assignment may be entered into in any number of counterparts, all of which taken together shall constitute one and the same instrument. Any party may enter into this Assignment by executing any such counterpart.




