RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT
(Enerwise)

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of October 31, 2014 (this "Release"), is made by made by **TRIANGLE CAPITAL CORPORATION**, as collateral agent (together with its successors, in such capacity, "Collateral Agent") under that certain Intellectual Property Security Agreement, dated as of November 27, 2012 and recorded in the United States Patent and Trademark Office on December 5, 2012 at Reel/Frame 029407/0566 (the "IP Security Agreement"), by and between Enerwise Global Technologies, Inc., a Delaware corporation ("Grantor") and Collateral Agent. Capitalized terms used and not defined herein have the meanings assigned to such terms in the IP Security Agreement.

WHEREAS, pursuant to the Security Agreement, Grantor granted to Collateral Agent a continuing security interest in and to all of Grantor's right, title and interest in certain Patents and Trademarks, including those listed on Schedules A and B attached hereto, respectively (the "IP Collateral").

WHEREAS, Grantor has requested and Collateral Agent has agreed to provide a document, intended also to be suitable for recording in the United States Patent and Trademark Office, evidencing and effecting the release, relinquishment and discharge of its security interest in the IP Collateral (the "Released IP Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent does hereby, (i) terminate the liens and security interest created under the IP Security Agreement in the Released IP Collateral, (ii) release its security interest in the Released IP Collateral, and (iii) discharge any and all rights, title and interest it has in and the security interest granted to Collateral Agent in the Released IP Collateral. Collateral Agent hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record the release, cancellation and termination of the security interests granted to Collateral Agent in the Released IP Collateral identified on Schedules A and B attached hereto.
