ARTICLES OF AMENDMENT

OF

MERCY MEDICAL AIRLIFT

FIRST: The name of the Corporation is MERCY MEDICAL ANGELS

SECOND: The Articles of Incorporation are restated as follows:

This Corporation is organized; and shall be administered and operated exclusively to receive, administer, and expend funds for charitable purpose within the meaning of Section 501(c)(3) of the following charitable purpose:

1. To ensure that no needy patient is denied access to distant specialized medical evaluation, diagnosis or treatment for lack of a means of long-distance medically-related transportation; further to ensure the provision of urgent transportation in situations of compelling human need and homeland security (disaster response) emergencies.

THIRD: The foregoing Amendment was adopted on May 21, 2013.

FOURTH: The Amendment was adopted by the affirmative vote of more than two-thirds of the Directors in office. Member action was not required for adoption of the Amendment because there are no members of the Corporation having voting rights.
