Trademark Assignment

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of October ~~31~~³, 2014, by and between Document Analytic Technologies, LLC, d/b/a Exemplify, a California limited liability company with offices at 317 Commercial Street NE, Albuquerque, NM 87102 ("Assignor"), and The Bureau of National Affairs, Inc., a Delaware corporation with offices at 1801 South Bell Street, Arlington, VA 22202 ("Assignee"), pursuant to the terms of that certain Asset Purchase Agreement by and between Assignor and Assignee (collectively, the "Parties"), dated as of October ~~16~~¹⁶, 2014 (the "Purchase Agreement").

Assignor hereby transfers and assigns to Assignee, its successors and assigns, and Assignee hereby acquires, accepts and receives from Assignor, Assignor's entire worldwide right, title and interest in and to the Trademark, including all applications and registrations thereof and all goodwill pertaining thereto, the right to conduct business under the Trademark, and all rights to sue, counterclaim and collect damages and payments for claims of past, present and future infringements, unfair competition or misappropriations thereof, and all income, royalties, damages and payments now or hereafter due or payable with respect to the Trademark.

2. Assignor consents to recordation of this Assignment by Assignee with the U.S. Patent and Trademark Office. Assignor agrees to execute, acknowledge and deliver any affidavits or documents reasonably requested and prepared by Assignee, to provide testimony (at Assignee's expense), and to perform any other acts reasonably necessary to carry out the intent of this Assignment.

3. This Assignment and the rights and obligations of the parties hereunder shall be governed by and construed in accordance with the laws of the United States of America and the State of New York applicable to contracts made and performed therein, without regard to any choice-of-law principle that would dictate the application of the laws of another jurisdiction.

4. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but both of which together will constitute one and the same instrument.
