## TRADEMARK ASSIGNMENT AGREEMENT

This Assignment Agreement is made by and between Arthur H. Garceau., a United States citizen with an address of 1625 Johnson Street, Hollywood, Florida 33020 (“Assignor”) and Ondine, LLC, a Vermont limited liability company (“Assignee”) (collectively referred to herein as the “Parties”).

WHEREAS, Assignor owns U.S. Registration No. 3,158,304 for the word mark ONDINE SUZANNE THIERRY (“Mark”) and common law rights in the Mark;

WHEREAS, Maya Boffa has filed an application to register the mark ONDINE with the U.S. Patent and Trademark Office (U.S. Ser. No. 86-209,002), which application Maya Boffa has agreed to assign to Assignee upon the filing of an amendment alleging use; and

WHEREAS, Assignee desires to acquire all common law and other rights to the Mark, and obtain an assignment of U.S. Registration No. 3,158,304 together with the goodwill associated with the Mark.

NOW, THEREFORE, for two thousand five hundred dollars (\$2,500) paid to the Assignor, the sufficiency of which consideration is hereby acknowledged, the Parties agree as follows:

1. Assignor agrees to and hereby does assign, convey and transfer to Assignee all of Assignor’s worldwide right, title, and interest in and to the Mark, together with the goodwill of the business associated with or symbolized by the Mark and the right to sue and collect damages for past, present, and future infringement thereof and all other benefits of the Mark.
2. Assignor consents to the recordation of this assignment by Assignee with the United States Patent and Trademark Office.
3. Assignor shall immediately cease and forego use of the Mark.
4. Assignor shall not oppose or challenge Maya Boffa’s application to register the mark ONDINE or any application filed by Assignee to register ONDINE or similar marks used with similar goods or services. Assignor shall not challenge Assignee’s use of the mark ONDINE or any other similar mark used with similar goods or services.
5. As consideration for the Assignment of the Mark and goodwill associated with the Mark, Assignee agrees to pay to Assignor the sum of \$2,500 (two thousand five hundred dollars in U.S. currency).
6. Assignor represents and warrants that it has the authority to transfer and assign all right, title and interest in and to the Mark to Assignee.

7. This Agreement will be fully binding upon, inure to the benefit of and be enforceable by the Parties and their respective successors and assigns.
8. This Agreement may be executed in counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.
