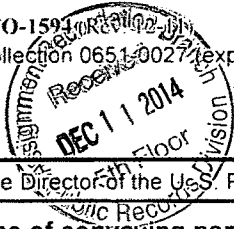

TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement") is made as of November 24, 2014 by and between IQ Health, LLC (the "Grantor"), a Florida limited liability company with offices at 950 Peninsula Corp Cir #3016, Boca Raton, Florida 33487 and Lewis J. Warshauer, M.D. and Janet G. Warshauer, joint tenants with right of survivorship (the "Lender"), having an address at 144 Viera Drive, Palm Beach Gardens, Florida 33418.

WHEREAS, Grantor and Lender are parties to that certain Loan and Security Agreement dated as of even date herewith (the "Loan Agreement") pursuant to which Grantor is required to execute and deliver this Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which by Grantor is hereby acknowledged, and to induce Lender to enter into the Loan Agreement, the parties hereto, intending to be legally bound hereby, agree as follows:


1. **Grant of Security Interest in Trademark Collateral.** Grantor hereby pledges and grants to Lender a lien on and security interest in and to all of Grantor's right, title, and interest in, to and under the marks set forth on **Schedule A** attached to and made a part of this Agreement (the "Marks"), the applications and/or registrations thereof in the United States Patent and Trademark Office (the "Registrations" together with the Marks being collectively referred to herein as the "Trademark Collateral"), together with any and all goodwill associated with the Trademark Collateral and relating to the business in connection with which the Trademark Collateral are used, and the right (but not the obligation) to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits.
2. **The Loan Agreement.** The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Lender pursuant to the Loan Agreement and Grantor hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan Agreement. In the event that any provision of this Agreement is deemed to conflict with the Loan Agreement, the provisions of the Loan Agreement shall control unless the Lender shall otherwise determine.
