RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby terminates the Agreement and releases, retransfers and reassigns to Grantor, without representation or warranty, all of Lender's right, title and interest in and to the Intellectual Property Collateral and the goodwill associated therewith.



