## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), dated as of July 3, 2013, is entered into by and between Heritage Dividend Fund, LLC, a Delaware corporation (together as "Assignor") in favor of liveBooks, Inc., a Delaware corporation ("Assignee").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of June 15, 2009, among the Assignee and Assignor, Assignee granted a security interest to the Assignor in certain collateral, including the trademark, LIVEBOOKS, Registration No. 3,053,437. (Exhibit A).

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on August 11, 2009 at Reel 4042, Frame 0156;

WHEREAS, Assignee granted to Assignor a security interest in all of Assignee's right, title, and interest in, to and under the Trademark, whether then owned or existing or at any time hereafter acquired or arising or wherever located, as collateral security for the prompt and complete payment and performance when due of Assignee's obligations. For purposes of this release and the Trademark Security Agreement, "Trademark" means LIVEBOOKS, the trademarks referred to in Schedule A, and the right to obtain all renewals thereof; and

WHEREAS, Assignor has agreed to terminate and release its security interest and all of its right, title and interest in the Trademark.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor and Assignee hereby agree as follows:

Assignor hereby releases and discharges its security interest in all of Assignee's right, title and interest in and to the Trademark, including, but not limited to the Trademark listed on Schedule A hereto, and reassigns and transfers any and all interest that Assignor may have in the Trademark to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to file this release with the United States Patent and Trademark Office, file form UCC-3 termination statements, or file this release in the applicable government office or agency.

Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments, and do any and all further acts which Assignee (or its agents or designees)

reasonably request (at Assignee's sole cost and expense) in order to confirm this release and Assignee's right, title, and interest in or to the Trademark.
