RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of December 31, 2014 by JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Administrative Agent") to CASSIDY TURLEY L.P., (the "Grantor"), as follows:

WHEREAS, on May 20, 2014, Cassidy Turley, Inc. (the "Borrower"), the Grantor, certain other Subsidiaries of the Borrower and the Administrative Agent entered into a Security Agreement ("Security Agreement") and the Grantor and the Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant");

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, the Grantor granted to the Administrative Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");

WHEREAS, said Confirmatory Grant was recorded in the United States Patent & Trademark Office on May 20, 2014, at reel/frame 5283/0943; and

NOW THEREFORE, as the Grantor has satisfied its obligations under said Security Agreement and Confirmatory Grant, the Administrative Agent hereby releases its security interest in and lien upon the Marks, and reassigns any and all interest it may have in the Marks to the Grantor.
