**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of December 31, 2014 by JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Administrative Agent") to CASSIDY TURLEY COMMERCIAL REAL ESTATE SERVICES, INC., (the "Grantor"), as follows:

WHEREAS, on May 20, 2014, Cassidy Turley, Inc. (the "Borrower"), the Grantor, certain other Subsidiaries of the Borrower and the Administrative Agent entered into a Security Agreement ("Security Agreement") and the Grantor and the Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant");

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, the Grantor granted to the Administrative Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");
